### THE POSITION

Nevada County Consolidated Fire District is seeking qualified applicants to fill Seasonal Firefighter Positions. The Seasonal Firefighter works under general supervision responding to fire alarms, other emergency and non-emergency calls involving suppression, extinguishment, and prevention of fires (structural and wildland), EMS and rescue duties; to protect life, property, and environment, including rescue and salvage operations. Seasonal Firefighters will maintain and repair fire station property and environment; train and drill for emergency preparedness; work may involve considerable physical exertion, and risk to health and safety; to use computers, and to perform related duties as required. Candidates are encouraged to review the position description for the Seasonal Firefighter position.

### MINIMUM QUALIFICATIONS

- Meets the minimum requirements for California State Fire Marshal Firefighter I Certification no later than July 1, 2022.
- Must possess a valid California Driver's License.
- Candidate must be at least 18 years of age.
- High School Graduate or GED equivalent.
- Possession of a current CPR certification meeting the requirements of the regional EMS authority.
- Possession of current certification as an EMT in the State of California.
- Basic computer and writing skills.

### SELECTION PROCESS

**Application Filing:** Applications will be accepted from May 6, 2022 to 4:00pm June 2, 2022. All applicants are to apply on-line at [www.nccfire.com](http://www.nccfire.com), and submit the required information as indicated on the job announcement, by the final filing date listed above. All applicants must clearly demonstrate that they meet the minimum qualifications provided on the job announcement. Resumes may not be substituted for the official application. Faxed, mailed, in-person or late applications WILL NOT be accepted.

**Application Evaluation:** Applications and Resumes will be reviewed by a hiring committee. The top qualified candidates will be invited to an interview process.

**Oral Interview:** The Oral Board will evaluate candidates in job-related areas. A DMV driving record (within 30 days) will be required at the time of the interview.

The Human Resources Department may change the examination steps noted above in accordance with the Personnel Management Regulations and accepted selection practices.
